Area 07 Chair's Report

At the last Area Committee Meeting (ACM) in July, the Finance Committee brought three separate motions under Old Business. They are as follows:

I propose CNIA-07 spend \$2500 to honor the Northern California Accessibilities Committee's (NCAC) funding request submitted to the finance committee on May 5, 2021.

I propose CNIA-07 spend \$1000 to support the Carry the Message Project with \$500 for Grapevine subscriptions \$500 for La Vina subscriptions.

I propose CNIA-07 make a one-time contribution to Oficina Latina Central for literature purchase.

All three motions passed with substantial unanimity. Thank you to the Finance Committee and our Area Treasurer, Margie, for all of their efforts.

Also at last month's ACM, we approved \$225 dollars for the Archives Committee to complete the renovations currently underway. I want to take this opportunity to thank all of our trusted servants who have helped in this process over the last two panels.

The California Northern Interior Area Archives will be holding their grand re-opening on September 4th from 11-3pm. The address and map for the Archives is located on the last page of the Accents. It is 1807 Navy Drive, Suite #11, Stockton, CA 95555. Please come and join us for this celebration! Food and refreshments will be provided.

Looking ahead to November's Election Assembly, this month I will be asking each of our Appointed Chairs and Area Officers to write an article for the Area Accents. The office is open 3 days a week. We are in the black after many months. 950-1,000 meetings weekly. We are transferring to Zoom phones since AT&T has raised the monthly bill. We added a cell phone to use Cash App and

Venmo. We are in need of a laptop to streamline service and literature sales at events. <u>www.aadelta.org</u>.

North Valley IG, Heather: (Butte, Glenn, Tehama) IG is meeting on zoom. Website has online and in-person schedules. Seeking new facility for speaker meeting. \$1200 remaining from funds to support groups impacted by the Camp Fire. We have \$10,000 to start up a Central Office. PI/CPC is with IG now, they had no active rep for 8 years. <u>https://aabutte-glenn.org</u>. **Fresno Intergroup**: Joshua G., Reyna B.: Meetings are still on zoom. Intergroup have

D09: No report

D11, Maureen R: We met 6/20 with 7 in attendance. 3 attended in March and April. REDYPAA is participating with us. We are in need of district trusted servants.

D15, Heather: 5-6 people met. Many groups have not re-elected GSRs. We passed district bylaws. Our new treasurer proposed a budget, which was approved.

D17: Lindsay G: More meetings are transitioning back in person. Dist. is meeting via zoom. We are navigating what to do with surplus funds and writing bylaws.

D19, Annette H: We met July 10 as a hybrid. More groups that lost their physical lo-

cations have found new homes. One group to stay online as members are now from a broader geographic footprint. Most groups report doing ok financially but still need contributions. Our Web Master is looking for resources to rebuild the website- frozen since March. We continue to update printed meeting schedules. Delegate report - Aug. 7. Unity Day - Sept. 25.

D20, Todd: We have found a temporary home. We met in person in July for the first time since Feb. 2020. Unity Day chair is reviewing indoor & outdoor locations. Venue and date TBA. We have new positions: CCFAA delegate and meeting schedules chair.

D21, Holly: Service committees meet monthly on event in the fall after difficulty finding a venue. Tuesdays. Met 6/22 with 8 GSRs, 5 officers and 1 member at large. About 27 participated pre-COVID and during COVID. We voted to keep business meetings on zoom. Upcoming: Fall Fellowship, Auburn "Recovery Happens", Placer homeless advocacy rally. www.aaplacer.org **D22**, Loren A: We hosted Founders Day with

100+ people. We voted to meet once a guarter in person. We are looking forward to hosting the 2022 Post-Conference assembly. West Slope Unity Group (El Dorado County to Pollock Pines): <u>www.westernsloped22.org</u>.

D23, Joe S.: Several of our meetings are resuming in person activities.

D24, Will K.: Former DCM Paul Z relocated. We meet in person 2nd Wed. 6 pm. We discussed reaching out to groups about General Service and if they have a GSR. Numbers have dwindled erate interest and understanding of the Area during COVID.

D25, Don H.: Our theme: keep passing it on, our responsibility to extend the hand of AA. Groups are transitioning. Finances are stable. District inventory: We discussed with committee, held two solutions meetings. Planning quarterly meetings; workshops/panels; create a website; get service sponsors. We're awaiting next steps for Twelve Steps checklist at ACM or Assembly. **D27**, Amanda A.: Quite a few meetings are starting to go back in person, but some are staying online. We discussed and voted on contributing unused funds from 2020: 20% GSO, 20% CCF, 60% Grapevine. Meetings are via Zoom, 1st Tues. after ACM. 15–20 attendees each month. We have had some new groups form online. **D29**, Patrick K.: June meeting via Zoom. The focus was "Rebuilding our District Post COVID." We plan to return to in-person meetings. 2nd Mon. Service Manual and weekly Grapevine

study continue on Zoom. Grapevine workshop Sept. 25 at Traditional Group.

D30, Michael: District meeting had 9 present. Most meetings are live. Upcoming Archives History Day with two speakers. www.cnia30.org. D33, Chel O.: D33 continues to transition through the "reconstruction period." 50% of meetings are in-person, a few hybrid. We met the 2nd Monday of July in person, twice as many people as in June. We are looking to fill a couple committee seats. We have asked groups for ideas to spend excess funds locally to carry the message. So far, \$2,000 for Grapevine and La Viña subscriptions. We may host a fellowship We look forward to hosting 2021 Winter Assembly.

D37, Mark: We have a new meeting place for a hybrid meeting. I have been trying to round up more GSRs by attending group business meetings.

D40, Carrie: We will continue to meet on Zoom for the next few months, and then reevaluate. We are planning Unity Day in September. Local meetings are continuing to adjust - in-hall, zoom and hybrid options.

Finance: Annette H read the Seventh Tradition (long form). Holly: We met this week. We are changing our proposal and will have other proposals at the August ACM. We received new requests for funding and chose not to act on them. **E-Services**, Emily: We met this month and will look forward to a conversation today to see where the next in-person location may be so we can see what equipment we may want for virtual or hybrid.

Bridging the Gap, Jason: I've passed along 4 cards from Area 06, 4 from a local facility, and 1 for a new member released in my home town. I am registered for the BTG Workshop Weekend in September in Illinois. I hope we can start to offer BTG in more facilities. Treasurer, Margie: I paid the final expenses to our accountant for filing our federal and state tax returns. I paid our state sales tax. At the minisharing session on June 27, we discussed the proposal to assist Oficina Latina Central. I continue to receive requests on how we can serve the area. Let us remember each group, district, and committee is autonomous; and each panel is autonomous.

Registrar, Herminia: The Accents lists were updated for July 2021 and emailed to Celia for processing. Group, contacts, mailing lists, and special reports continue to be updated. A few GSR forms were processed. I will be emailing the updated Area Committee List in August 2021. It was wonderful to visit the Archives and be of service. Alt Chair, Claudio: I carpooled with Jenn and Tom to the linguistic interdistrict meeting. Attended D24 meeting. I encourage districts to do a field trip there. I registered for BTG Workshop Weekend. Upcoming: D29 meeting; D34 Anonymity Workshop. Just want to remind you to bring the enthusiasm for general service. You are the spark that will light the fire with trusted servants. It's time for us to try and reignite that fire with people, starting with our home groups.

Alt-Delegate, Jenn: Participated in North American Alternate Delegates' meeting and April PICPC Working Group meeting. Participated in monthly officer's conference call and E-Services meeting. Participated at linguistic Interdistrict meeting. Events: D34 anonymity workshop (Aug 8), D34 service workshop (Oct 2), speaker at Area Unity meeting (July). PICPC chair: Received email from CCF about their PICPC committee. Please send me your district's PICPC contact information. E-Services: Discussed potential needs to provide hybrid meetings. We will need to discuss the possibility of getting our own Zoom account with interpretation services. We transitioned to a new Zoom account through 2021. National AA Technology Workshop will be online, Sep 17-19: naatw.org. GV/LV Carry the Message: Please consider asking your district or home group to take part. www.aagrapevine.org/ carry-the-message

Delegate, Tom: Are we hearing conversations about changes made at the Conference? We should embrace this discussion. It's an opportunity to explain how WE make changes; inclusion and who is not here; asking "was anybody harmed in making the change?" The Conference spoke for the Fellowship (and it was beautiful). The more we explain in our fellowship, the greater understanding we will have how these changes come about.

<u>Delegate Reports</u> are continuing. I am doing my best to get the information on our web site. All are welcome. Reports have taken different forms – questions, reporting on advisory actions, explaining events at the Conference.

<u>Events</u>: Virtual Trusted Servants Meeting (July 18): Keeping virtual members as part of the whole; give those members a voice at business meetings. / D19 and D29 reports / D34 anonymity workshop (Aug 8) / Archives Open House (Sept 4).

<u>Pacific Regional Delegates</u>: Met w/ Kathi F., Pacific Regional Trustee. She has not met with us since the Conference.

<u>Grapevine</u>: Circ. down slightly from 2020. Net Income: \$269K YTD includes insurance, \$180K. <u>La Viña</u>: 25th anniversary this year. Circ. way down, approx. 5,800. Hoping to see a rise with in -person events. Currently operating at a loss, YTD figure not yet available. Please pass along the GV/LV Instagram info. We are moving forward on new podcasts. Prayer and Meditation

book can be pre-ordered and will be sold outside of AA. Hope to have Publisher position filled by Board Weekend.

AAWS: Expenses down due to retirements and furloughs. Contributions: \$4.3M YTD, 44% of 2021 Budget (5/12 = 41.667%). Contributions have not exceeded \$1M in any month this year (\$862K average). At that rate we will have \$10M. Gross Sales are over \$1M in April. The fellowship has rallied; their support is appreciated. New York taxes have increased. Cash on hand: about \$1.2M, \$641K in budget. Operating Capital is 1.2 months of operating expenses. During Board Weekend, there will be talk about beginning to replenish the Reserve Fund with this surplus. Preliminary estimated publication schedules: July: 12x12 soft cover (eventually all will be updated); Faith Leaders pamphlet. August: 71st Final Conference Report. September: Hispanic Women in AA: new Twelve Traditions Illustrated: new GV video; sample text for the Plain and Simplified Language Big Book (Trustees Committee on Literature will see what it looks like). October: Big Book CD set; Our Great Responsibility e-book. November: Service Manual. December: Spanish edition of Experience, Strength and Hope. International Convention: 2025 Vancouver, BC. In search of a theme.

<u>Regional Forums</u>: Open registration: West Central, virtual Sept 10-12. Southwest, virtual Oct 8-10.

<u>Agenda Items</u>: An item can be submitted any time throughout the year. The deadline for the 2022 Conference is Sept. 15.

Old Business: Finance Committee spending proposals. Matthew asked for clarification on the Finance Committee's proposal to amend its June 2021 motion. Holly (Finance Chair) presented: *After careful consideration of suggested ideas to provide funding to carry the A.A. message to alcoholics, I propose that CNIA-07 consider the following funding proposals to address service needs in our area.* Approved expenditures for 2021: \$84,935. Expenditures approved at ACM limited to 5% total: \$4,625.75. Today's three motions would total \$4,000.

Item 1. Holly moved, Patrick K (DCM) seconded: *I propose CNIA-07 spend \$2500 to honor the Northern California Accessibilities Committee's (NCAC) funding request submitted to the finance committee on May 5, 2021.* Matthew requested the Finance Committee read the NCAC letter. There was no discussion. We decided by poll to call the question. We voted 95% to 5% and heard no minority opinion. Motion carried. **Item 2**. Holly moved, Julie (DCM) seconded: *I* propose CNIA-07 spend \$1000 to support the Carry the Message Project with \$500 for Grapevine subscriptions \$500 for La Viña subscriptions. Clarification, to purchase hard copy subscriptions to be managed by Grapevine and La Viña staff.

Discussion: No figures available on who are requesting, but requests are about equal to the number donated. // We could budget for 2022 to support members within CNIA. / If we contribute to just our area, it could take away the opportunity for home groups. / Tom- Pacific Regional Trustee, Kathi F, said she doesn't want to have so much demand that we aren't able to provide it. / H&I Volunteers can pass along information on how to request a subscription. Refer to July 2019 letter from an incarcerated alcoholic about Carry the Message. H&I can provide magazines depending on the facility. We unanimously decided by zoom poll to call the question. We voted 95% to 5% and heard no minority opinion. Motion carried.

Item 3. Holly moved, Patrick K. (DCM) seconded: *I propose CNIA-07 make a one-time contribution to Oficina Latina Central for literature purchase.* A lot of meetings did not transition to zoom, they were not getting Seventh Tradition contributions, and they were not able to purchase literature for members. Clarification: \$500 contribution. [Motion was not amended to include amount.]

<u>Discussion</u>: They did not specify what literature. Would recommend purchasing from local intergroup rather than give money.

We decided by zoom poll to call the question. We voted (95% to 5%) and heard no minority opinion. Motion carried.

Old Business: Online groups

Alt-Delegate, Jenn: An online group that considers itself to be in Tulare County wanted information on how to register with GSO. One of the 71st Conference Advisory Actions was allowing groups to register in their choice of district in an area as full participating groups. Not all districts will be able to host an online hybrid meeting to allow the GSR to fully participate. As we think about district meetings and assemblies, we need to think about how to encourage the best possible participation.

<u>Discussion</u>: If an online group doesn't pick an area and district, it is designated "Area 95" by GSO. Area 95 does not have a Delegate or DCMs. Online groups were not "real" because they did not have representation. Alaska's area has a district for phone meetings and online meetings. / If someone is not physically at an assembly, could they write in their ballot? / A hybrid option would be needed, there would be too many variables. / My home group just split. Some members are staying on zoom, including our GSR. / If an online group wanted to participate in the Conference, we can have some suggestions. We may have greater feedback at future Conferences.

Old Business: ACM location

Chair, Matthew: The building where ACM and East Yolo Fellowship met was sold. Let me know if you would like to participate on the ad hoc committee. <u>Discussion</u>: Could talk to EYF about using their new location / Needs to accommodate 50+ people. We are following state and local guidelines. / Requirements for a future landlord. / Many churches have large meeting rooms and may have events on Saturdays. / Maybe the Area Committee should decide general parameters.

New Business: Archives supplies

Jeff, Archivist: We have spent \$853 of our \$950 supply budget. We need to purchase paint, frame more pictures at \$80-\$90 each, and refreshments for the open house. Jenn (Alt-Delegate) moved, Maureen (DCM) seconded: / would like to make a motion for the supply budget for the archives this year be increased by \$250.00 to pay for the remodeling of the archives and the cost of the open house. Discussion: Concern re. spending under miscellaneous line items. "Refreshments" line could be created. / Jeff said volunteers provide food on a potluck basis. The open house would be a onetime cost. / Spending approved at ACM cannot exceed 5% of the year's approved expenditures. \$250 would exceed the limit. / The Area Chair suggested tabling to August 2021 to clarify amounts and process. He entertained an amended motion, changing to \$225.00 to stay under the 5%. Seconded by Holly. Discussion: CNIA service material says the Finance Committee must consider any unbudgeted or unanticipated impact of more than \$300. The Finance Committee can consider items under \$300. This panel's spending has not been

normal. We haven't spent much of existing line items. The 5% restriction may limit our ability to entertain proposals for the rest of this panel. / Matthew said we could continue discussing at a future meeting. We decided by zoom poll to call the question. We voted (96% to 4%) and heard minority opinion to change to a different line item from Supplies. Three people said they would change their vote. <u>Motion to reconsider</u> entered by Margie; seconded by Rafael (DCM). Reconsideration failed 33% to 67%.

New Business: Nor Cal bid for ICYPAA letter CNIA liaison, Teddi: Looking for a letter of spiritual support from CNIA to bring the conference to Northern California (Areas 06, 07 and 42). ICYPAA is in New Orleans Aug 26-29. The bid package is due Aug 1. Re. conflicts, the bid includes a list of local events. If selected, the event would likely be in San Francisco, Labor Day 2022. / We agreed unanimously to provide the letter.

New Business: Gifts for use of office space Delegate/Tom: I have been able to use an office in Cameron Park for all events other than the Conference. The owners do not know it is AArelated. No one has expected compensation. The staff member who opens and closes the office has been dependable and respectful. / Tom made two requests: A plant for the office manager, not to exceed \$50, and a \$250 gift card for the staff member. We adjourned at 4:00 pm with the Responsibility Declaration.

Experience and Love in Our Service Positions Panel 70

E-Services Chair

I am so grateful to have had the opportunity to serve for CNIA as your e-services chair this panel. I vividly remember coming to the winter assembly back in January 2020 after being asked to speak on a panel about "Our Great Responsibility." I shared about my experience as a GSR, having been a GSR for my home group for a few years, and then having served as the alternate DCM for District 27. ! knew at that time that I couldn't fathom not being involved in general service, but I didn't know what it was going to look like. I remember hearing our chair talk about the need for an e-services committee chairperson and knowing that I could be available for it – as I figured I had a little bit of previous web design experience.

This has been a unique panel for everyone, but I would say especially so for the e-services committee. When I made myself available for the position I was told that I'd be responsible for making sure the website was up to date, posting the Accents monthly, and also being in charge of the assisted listening/translation devices and the PA system. Obviously...we moved completely virtual shortly after that, and the position has felt very different at some points over the past year or so.

At its core, the position is still the same as it's listed in the CNIA Service Material Book: the committee is responsible for addressing the communication needs of the Area. 
GSR Preamble


Area General Service Meetings
