2021 Post-Conference Assembly

Area Chair, Matthew L., called the California Northern Interior Area Post-Conference Assembly to order by zoom videoconference, Saturday, May 15, 2021 at 9:00 am with the Serenity Prayer. Valerie read the GSR Preamble. Mike read the Twelve Traditions (short form). Keith read the Twelve Concepts (short form). Nancy read "Why do we Need a Conference?".

Introductions: Matthew introduced CNIA Past Delegates Mike K., Panel 68; Vikki, Panel 66; Melody, Panel 60; Marianne, Panel 58; Inez, Panel 44. Visitors, guests and first-time attendees were invited to introduce themselves.

We had a roll call of districts followed by remarks from the host district (D11) DCM, Maureen. The Weekend Overview was given by Marianne H., CNIA Past Delegate, Panel 58.

Treasurer, Margie, described how to make Seventh Tradition contributions.

ASSEMBLY REPORTS

Matthew reported that we have decided to stay on zoom for the rest of this panel. During today's business meeting, we will discuss a motion to meet in person for the Election Assembly.

thew read report: Due to continued CDC, state and county guidelines, we have cancelled all conferences for 2021. Deposits were returned from Rocklin and Lodi. Next event: San Jose Holiday Inn, March 2022. **Central Valley Intergroup**: No report. **Fresno Intergroup**, Joshua: There have been some upgrades to the building. **North Valley Intergroup**: No report. **Norcal Intergroup**: No report. **Norcal Intergroup**: No report. **Northern California Accessibility Com**-

mittee, Delia: Meetings on 2nd Saturdays, 10–11 am. May 8: Discussed Uber program. June–Dec. 2020: completed 19 rides to meetings, 6 not completed due to unavailable drivers. 2021 YTD: 17 rides requested. 6 driver no-show, 2 pre-scheduled for May. Invited Past Delegate Melody T. to share about welcoming members with neurodevelopmental impairments, traumatic brain injury, and autism. We invite accessibility chairs from other areas to talk about improving services. Rides are available throughout the area, 24 hrs advance notice preferred but we try to fill last-minute requests when available.

Hispanic Women's Workshop, Lorri A.: 6th annual event, 12/4 Tempe, AZ, possibly in person. Committee meets on zoom 2nd Sat, noon. 6 areas attended the last meeting. The deadline for art submissions is July 13. Area speaker deadline is Sept 20. A meeting in New Mexico requested a visit from the committee.

D09: No report

D11, Maureen: D11 is continuing to open meetings. We are financially solvent. We have not made many splits since covid but we are getting ready to make a substantial split soon.

D15, Lisanne: Most intergroup and D15 positions are filled. Sierra Bible Camp will allow our campout. We are seeking coordinators. We are opening meetings in person outdoors **D27**, Amanda: We meet online 1st Tuesday and a few indoors. We have a schedule on the website. We are looking for officers and are continuing to work on bylaws.

D17, Lindsay: We are reviewing a draft of new bylaws. We are reaching out to groups who are not connected to the District. We are planning a workshop for this summer. D19. Annette: Met 5/1 with 7 GSRs. Our first F2F+ district meeting took 20 minutes to figure out Zoom. We are updating a printed schedule. A large fellowship, Keystone Group, will reopen in a new location. **D20**, Todd: Many meetings are in person,

Thank you to all who send their reports to me and our Oral Translator, Jose, in advance, and to our Written Translator, Amanda, for translating the email reminder. I attended D30 Unity Day and CCF's PICPC meeting.

Treasurer, Margie: I've shared my experience, strength, and hope at several meetings this month. I continue to receive and deposit contributions from our groups. Some write notes that they are meeting in person or have tion Assembly as an in-person event. a new treasurer. I'm possibly hosting another sharing session for treasurers in June. Currently, we have a deficit but I am entering deposits. The Finance Committee met 5/5. Looking forward to getting your feedback on some ideas on how to spend down our excess funds.

Alt-Chair, Claudio: I've been preparing the assembly agenda. With challenges and difficulties we go through, it always works out. Thank you to Tom for helping get speakers. This is our 7th assembly of the panel. It's been an honor serving.

Chair. Matthew: I felt like there was a nice break in AA and service the past couple weeks. We were busy leading up to the Pre-Conference. I got to chair a couple meetings and speak with people I haven't talked to in a while. Went to an in-person meeting and D30 Unity Day. Attended D29 and talked about the Post-Conference Assembly. Please invite me to your district meetings. Attended unity meeting with appointed chairs presenting.

OFFICERS, CONTINUED

Alt-Delegate, Jenn: Participated in monthly North American Alternate Delegates' meeting and April 2021 PI/CPC Working Group. Participated in monthly meetings with CNIA officers and E-Services committee. The National AA Technology Workshop's steering committee changed to an online event (Sept 17–19, naatw.org). Please consider asking your district or home group to take part in the Carry the Message Project with gift subscriptions for alcoholics and PICPC committees.

We had a Q&A session with the Delegate. **OLD BUSINESS**

Continued discussion: Pre-Conference Assembly motion to host the 2021 Elec-

- Area Chair, Matthew, noted that area officers had already voted 6 in favor, 1 abstention, to remain online for the rest of the panel.
- We discussed changes in state and local guidelines, such as distancing, wearing masks, requiring a negative test result or vaccination, and the ability of the Area to make changes if conditions change. It was asked how the area would support inclusivity with people who may be at high risk of covid or cannot be vaccinated.
- It was said that some districts are discussing and voting on whether to attend online or in-person district meetings and assemblies. Some districts and groups do not currently have adequate funding for travel to assemblies. A concern was raised about choosing who would get to attend if the event is over capacity. We also discussed venue rental rates, deposits, and limitations on outside food and drink.
- We talked about conducting the Elections Assembly as a simultaneous in-person and online hybrid format. A hybrid assembly was not part of the motion.
- It was asked whether participation is lower now than pre-covid, and that some people may choose not to attend regardless of online or in person. We also discussed the convenience of zoom and features such as chatting and breakout rooms, and in-person events where we may have side conversations, encourage people to share at the mic, visit display tables.
- If it's possible, let's continue planning, and if not, let's not do it. Possibly easier to switch from Zoom to in-person than vice versa.
- D24 clarified that they are looking for another venue. A venue was secured by February and was unable to be rescheduled after the assembly was

changed to the 2nd weekend of November. Another venue was pending in April and the deadline to commit had lapsed.

The question was called and seconded, and all we were ready to vote. Vote result by zoom poll: 14 in favor, 20 opposed. Substantial unanimity was not reached and the motion was defeated.

A point of order was raised, that a poll is a completely different way of voting, as CNIA has conducted business by a show of hands. <u>Minority Opinion</u>:

- It's easier to start planning for an inperson event and cancel it later.
- If D24 doesn't present a facility and hotel rate by June 19, the assembly would automatically default to Zoom. We could have other rules in place by then.
- If the area officers already made a decision why are we discussing and voting?
 - Matthew reiterated that it was decided in February to plan the assembly on zoom. The host district put forth a motion because they wanted to have it in person.
- <u>Hybrid meeting</u>: The motion says "venue or platform" so I took that to mean it could be a hybrid. // If the vote passes, we might have the opportunity to do a hybrid. // The Pre-Conference minutes in the Accents say we could not do a hybrid meeting because we don't have the technology.

<u>Reconsideration</u>: A motion was made to reconsider. The motion was not seconded; vote stands.

Additional discussion

- We are a self-correcting fellowship. The area made the best decision they could with the information they had at the time.
- It was mentioned that some don't know if they will be comfortable being a room with hundreds of people again. A DCM said their district was split evenly to attend in person, about 20% would go

in person but online was preferred and 14% would not attend in person.

- Someone noted that 87 people were online during Tom's report, currently 56.
- Why couldn't it be a hybrid meeting for those who don't feel comfortable?
- This wouldn't be the first time we didn't have a venue 6 months out.
- Our trusted servants and GSRs have not been able to do their jobs. We should give them the opportunity to meet in person.

NEW BUSINESS

Funding Proposals in response to the Finance Committee's recommendation to state a purpose for, and spend down, our accumulated funds. Moved and seconded to extend the meeting by 15 minutes to allow the motion to be read.

- I propose that the Area approve spending \$5800 to spend down some of our accumulated funds according to the finance committee's recommendation as follows: NCAC funding request: \$2500 Carry the Message Project (\$500
 - GV/ \$500 LV): \$1000
 - One-time contribution to Oficina Latina Central to purchase literature: \$500
 - A one-time additional delegate reimbursement to GSO (we currently pay \$3200): \$1800 Total to payout now: \$5800
- Translation Services

I propose that the Area approve spending in the amount of, up to \$7400/year to provide Spanish translation at all of our Area Assemblies as follows:

Professional Spanish Translator(s) for the full-day (Saturday) at each Area Assembly, not to exceed \$1450 per assembly for two translators all day (up to \$5800/year). Pay our Oral Translator/Translation Team (members) to cover the Friday and Sunday portions at all Area Assemblies according to the following scale: \$40/hour for two-hour block and \$60/hour if one translator translates for 3 or more hours without a 2-hour break (\$240-\$320 for a 6-hr day; 3 2-hr. blocks); Up to \$1600/ year for 4 assemblies I propose that the Area approve spending in the amount of, up to \$2560/year to pay our Oral Translator/Translation Team (members) to provide Spanish translation at all of our Area Committee Meetings (8) according to the following scale: \$40/hour for two-hour block and \$60/hour if translating for 3 or more hours without a 2 -hour break (\$240--hr. blocks) I propose that the Area approve

spending in the amount of, up to \$4000/year to provide ASL Interpretation services at Area Assemblies, upon request by any group or member that requests this service need (reserving opportunity to revisit and increase this amount as funding permits, if there is an ongoing need).

Discussion

Having excess funds is plaguing us, from small groups and fellowships all the way to the World Services office. // Our area is Sacramento-centric with services. // Writing a check is not the answer.

- NCAC: Asking for help to fund Uber service to get people to meetings. NCAC has \$3,300 anticipated to last through November. The service only works in places with Uber, which is a non-AA entity we do business with. Some areas don't have as many Uber drivers. When you contribute to GSO, you're going to help people you've never met. This service is in our area. // It was asked whether groups other than NCAC were invited to share at the finance committee. NCAC was the only group that made a request. // A visually -impaired member shared that it's often hard to get a ride but that Uber was doing pretty good.
- <u>Translation Services</u>: Finance Chair said the proposals were based on the committee's discussions and talking with Tom about other areas.
- <u>Oficina Latina Central</u>: Finance Chair said they needed funds because they ran out of contributions and literature
- <u>Carry the Message Project</u>: One or two people commented in support
- Additional contribution to GSO: No comments

\$320 for a 6-hr day; 3 2 Matthew continued the discussion to June -hr. blocks) 2021 ACM.

We closed the assembly with the Responsibility Statement at 5:48 pm.

Delegate

Are You Available to Serve? Saying "Yes" to a Spiritual Journey

Early in my General Service experience, I heard "Begin where you are. Step out in faith. Do what you can, gracefully. Expect God to help." This spiritual journey of service starts with saying "yes". I didn't know where it would lead me but I had faith that I would be shown what to do next to best serve Him.

In November of 2019, I was elected the Panel 70 Delegate for the California Northern Interior Area (CNIA) 07 at our Election Assembly in Lindsay, CA. The congratulatory responses included words of wisdom from Past Delegates: "Have an experience", "Don't blink", "This is going to be an amazing journey". Despite the fact that no one would have predicted what we were about to experience over the next two years, these words rang true.

Panel 70 has been unlike any preceding Panel, changes in how we meet, communicate and serve has taken on a new look. Much of what we have done in AA over the last two years has been in a virtual setting and may be a part of how we do things in the future but the general duties of the delegate have not changed.

The duties of the delegate can be found in are 2020/2021 CNIA Service Material Book. A few of the duties include:

Know and understand the feelings and informed groups conscience of the members within the Area concerning General Service Conference Agenda Items.

Enhance the communication from the groups to the General Service Conference and back. Attend the General Service Conference, prepared to express the conscience of the Area as a result of having presented and discussed the Conference Agenda Items throughout the Area during the months preceding the Conference.

If you are considering making yourself available to serve as the Panel 72 CNIA Delegate, please read the 2018-2020 Edition A.A. Service Manual, Chapter 6, "The Delegate" on page S50. The first sentence reads:

"The delegate has a demanding job, not only because a large amount of time and work are involved, but because it is the delegate's responsibility to serve the US/Canada Conference as a whole."

Here are some suggested qualifications to best perform the duties as Area Delegate:

• Several years of active participation in local and area affairs, as a G.S.R. and as a committee member.

• Time available, not only for the week-long Conference meeting in April but for all the efforts needed before and after the Conference.

• Five or six years of continuous sobriety. The sobriety requirement varies from area to area; in any case, a delegate should have been sober long enough to be responsible and informed.

• The ability to make and take suggestions—and criticisms, too.

• Experience in chairing meetings.

• Knowledge of A.A. affairs, and of where to find the correct information when they do not **know** the answers.

• Thorough familiarity with the Twelve Traditions and the Twelve Concepts and how they apply to local problems.

• The ability to be open-minded, to sit down with A.A.s in the area and with other delegates to discuss and act on matters vital to A.A.

If you are thinking about standing for a term as delegate, ask yourself these questions: • How well did you do as a G.S.R.? As a committee member? Did you enjoy the responsibilities? Were you active?

•Have you discussed the possibility with your family and your employer? Will the time be available for the amount of work required?

•Are you familiar with this manual? With A.A. Comes of Age? And of course, with the Twelve Steps, Twelve Traditions and Twelve Concepts?

•Have you talked with past delegates to get an idea of the time and effort required and the sort of work you will need to do?"

I am grateful to have been a part of a resilient General Service Conference process and an Area that worked their way through these trying times with love and grace. This journey has been an amazing opportunity for growth and I will be forever grateful for the opportunity to serve Alcoholics Anonymous and CNIA. I look forward to saying "yes" to my next service position - Incoming Past Delegate.


GSR Preamble


