Summer edition Box 4-5-9 had an article about covid's impact to last GSC - it was removed but is now back up. Accessibilities/Treatment: gathering more stories for the "AA for the Older Alcoholic" especially more diverse representation due Sept 23. CPC: LinkedIn page has >2000

followers and several new posts. International: the desk conducted a GSO Sweep to update contact info for the International GSOs. Literature: created a submission tool for the AA webpage. PI: two new PSAs already have been picked up by news media sources 534 times, with a total potential audience of 192,067,172. Membership survey planning is underway - 13 groups in our area were chosen. Discussing QR codes for published literature. Regional Forums: North/South Connections Virtual Special Forum was held in collaboration with Argentina and Chile July 16. Archives: Trustee emeritus Ward Ewing donated AA related work papers that were organized and preserved. Work papers and other materials from the daughters of former GSO staff member Eve M (employed at GSO circa 1954-68) were periodically shipped to the office - final shipment was in July. Finance: Year-to-date contributions (six months ending June 30, 2022) are \$5,011,648. This represents 50% of the 2022 budget of \$10,000,000 (with 50% of the year elapsed) and is \$35,332 more than last year. YTD 22% of contributions have been online. Publishing: our executive editor is on a medical leave so some projects are delayed. Publishing is looking at a way to keep new pamphlets updated (not waiting until old inventory is gone to print new versions). Looking at a jacket-less format for the next BB printings.

Comments/questions: For Accents what is the difference between production and printing? Printing company does postage/folding/ processings. What is the line item for GSC under miscellaneous? Air fair, hotel, cost for delegate - it's not under delegate because it's our contribution to GSO rather than an expense of the delegate (the 1100 under Delegate is walking around money during the GSC). Someone shared they feel that funding every officer and appointed chair (and alternate) to attend PRAASA feels excessive. Someone asked if the \$600 we just approved for the Hispanic Women's Conference is included. It is not.

Greetings, fellow trusted servants. Thinking back to my first personal inventories, it was suggested to look at my life and actions— good, bad, and indifferent. To see what I've done well, where I've gone off the beam, to set things right, and not wait too long between house cleanings. In a similar way, the time is upon us to take the area's inventory, as we do every other year at our Mini PRAASA Assembly. This is our opportunity to consider how we carry the Area's informed group conscience and meet our responsibilities in the General Service structure.

In the years ahead we shall, of course, make mistakes. Experience has taught us that we need have no fear of doing this, providing that we always remain willing to confess our faults and to correct them promptly. Our growth as individuals has depended upon this healthy process of trial and error. So will our growth as a fellowship. Let us always remember that any society of men and women that cannot freely correct its own faults must surely fall into decay if not into collapse. Such is the universal penalty for the failure to go on growing. Just as each A.A. must continue to take his moral inventory and act upon it, so must our whole society do if we are to survive and if we are to serve usefully and well. – Alcoholics Anonymous Comes of Age, p. 231


GSR Preamble


